

# 政府「全日制大專學生免入息審查貸款計劃」2024/25

## 申請辦法(新生)

「全日制大專學生免入息審查貸款計劃」是由政府在职家庭及學生資助事務處轄下的學生資助處(學資處)提供的貸款計劃。申請人無須通過入息審查,最高貸款額為該學年應繳學費的總額。詳情請參閱學資處網頁<https://www.wfsfaa.gov.hk/tc/sfo/postsecondary/nlsft/overview.php>。

### 申請資格

- ◇ 申請人須為香港中文大學註冊的全日制學生;
- ◇ 申請人須就讀學額全數由政府大學教育資助委員會或公帑所資助的認可課程,有關認可課程的課程編號一覽表,可瀏覽學資處網頁<https://www.wfsfaa.gov.hk/tc/sfo/postsecondary/tsfs/coding.php>;
- ◇ 申請人須擁有香港特別行政區(「香港」)居留權,或在課程開始前,申請人或其家庭已連續在香港居住滿三年。這並不包括持有香港學生簽證/進入許可證的非本地學生;及
- ◇ 學生只可於同一學年內,就一個合資格的全日制課程申請資助。

### 網上遞交申請

- ◇ 申請人可透過政府「學資處電子通 - 我的申請」網上平台<https://e-link.wfsfaa.gov.hk> 遞交申請,新生網上遞交申請的截止日期為**2024年9月27日**。

### 遞交聲明書及證明文件

- ◇ 同學必須於遞交申請書日期起計**七天**內,將已簽妥的聲明書(如選擇書面簽署)及申請所需的證明文件副本上載、郵寄至學資處或投入設於學資處的收集箱,同學亦可於**2024年9月2至10月4日內的星期一至五(公眾假期除外)**上午8時45分至下午1時及下午2時至5時30分,把有關文件投入設於本校康本國際學術園12樓1206室入學及學生資助處獎學金及經濟援助組的收集箱。
- ◇ 所有以空白的A4紙張列印的副本必須清晰可讀。列印在已用過的紙張上的文件將不被接納。同學請將已簽妥的聲明書(如選擇書面簽署)及申請所需的證明文件,預先用釘書機釘好才遞交。

### 注意事項

- ◇ 同學必須於遞交申請前,仔細閱讀「申請指引」,該指引已上載於學資處網頁<https://www.wfsfaa.gov.hk/sfo/pdf/common/Form/nls/NLSFT111A.pdf>。
- ◇ 同學填寫申請書時,請參考政府「學資處電子通 - 我的申請」網頁<https://ess.wfsfaa.gov.hk/demo/tc/index.html>的網上示範。
- ◇ 申請是項計劃的行政費為港幣296元,同學可透過匯豐銀行或恆生銀行自動櫃員機轉帳或親身前往匯豐銀行分行以現金繳付行政費,並將已繳付行政費的交易資料於填寫網上申請時的「第5步」上載至網上申請系統。同學亦可於遞交網上申請時,透過信用卡或轉數快支付系統帳戶即時網上繳費。信用卡付款僅接受VISA、萬事達卡、銀聯和JCB。
- ◇ 學資處會向成功申請人發出「發放貸款通知書」,列明免入息審查貸款的發放金額及日期。免審查貸款會直接發放予中大,用作支付學費。入學及學生資助處會透過中大電郵(CUHK@link)聯絡在貸款發放日期前已繳付學費的申請人,提供銀行戶口資料以便把貸款存入申請人的銀行戶口。
- ◇ 若申請人因經濟困難未能繳付學費及在學費到期日前仍未收到「發放貸款通知書」或免入息審查貸款的發放日期遲於學費到期日,同學可申請延期繳交學費。有關申請詳情,本科生可向所屬書院查詢,研究生請聯絡就讀課程部門。
- ◇ 學資處會在發放「資助專上課程學生資助計劃」的申請結果通知書內,同時通知申請人按「全日制大專學生免入息審查貸款計劃」可獲得的貸款額。假如申請人希望接受有關貸款,可於學資處網頁下載貸款文件,並於「資助專上課程學生資助計劃」通知書上所示日期或之前,將填妥的貸款文件連同其他所需證明文件郵寄至學資處或投入設於學資處的收集箱。
- ◇ **若同學就讀深造(研究式)課程**,而該課程於2024年3月至2025年2月期間開始,便應申請2024/25學年的貸款。截止日期為課程開始後一個月。在任何情況下均不可遲於2025年3月31日遞交申請。

# Non-means-tested Loan Scheme for Full-time Tertiary Students (NLSFT) 2024/25

## Submission Guidelines (New Students)

The Non-means-tested Loan Scheme for Full-time Tertiary Students (NLSFT) is administered by the Government Student Finance Office of the Working Family and Student Financial Assistance Agency (SFO). It provides non-means-tested loans to students up to the amount of payable tuition fees. For details, please visit the website of SFO at <https://www.wfsfaa.gov.hk/en/sfo/postsecondary/tsfs/overview.php>.

### Eligibility

- ✧ Applicants should be registered as a full-time student in The Chinese University of Hong Kong;
- ✧ Applicants must take up exclusively UGC-funded or publicly-funded student places of recognized programmes. The Course Coding Sheet of the recognized programmes is available at SFO's website: <https://www.wfsfaa.gov.hk/en/sfo/postsecondary/tsfs/coding.php>;
- ✧ Applicants should have the right of abode in the Hong Kong Special Administrative Region (Hong Kong), or alternatively, applicants or their families must have resided in Hong Kong continuously for 3 complete years prior to the commencement of the programme. This does not cover non-local students holding student visas / entry permits; and
- ✧ Students can only submit an application for one eligible full-time course in any particular academic year.

### Online Submission of Application

- ✧ Applicants may submit their applications through “SFO E-link – My Applications” online platform at <https://e-link.wfsfaa.gov.hk>. New students should submit their online applications **on or before 27 September 2024**.

### Submission of Declaration and Supporting Documents

- ✧ Applicants are required to submit the signed Declaration (if opted for paper signing) and supporting documents within **7 days** from submission of online application form by online uploading, by post or to the collection boxes at SFO's office. Applicants may also submit the documents to the collection box at Scholarships and Financial Aid Section, Office of Admissions and Financial Aid at Room 1206, 12/F, Yasumoto International Academic Park from 8:45 a.m. to 1:00 p.m. and 2:00 p.m. to 5:30 p.m., **Monday to Friday (except public holidays) during 2 September to 4 October 2024**.
- ✧ Please ensure all copies, printed on blank A4 white paper, are clear and readable. Documents printed on used paper are not accepted. Applicants should staple the signed Declaration (if opted for paper signing) and the required supporting documents together before submission.

### Notes

- ✧ Applicants should study the “Guidance Notes” before submitting their applications. The Notes are available at <https://www.wfsfaa.gov.hk/sfo/pdf/common/Form/nls/NLSFT111B.pdf>.
- ✧ Applicants may refer to the online demonstration at the homepage of SFO E-link – My Applications (<https://ess.wfsfaa.gov.hk/demo/en/>) when completing the application form.
- ✧ The administrative fee for applying for this Scheme is HK\$296. Applicants may pay the administration fee by transfer via ATM of HSBC or Hang Seng Bank or paying cash in person at branch of HSBC. When completing the online application, transaction advice or account deposit form should be uploaded at “Step 5” of the online form. Applicants may also pay the fee instantly online by a credit card or Faster Payment System (“FPS”) account when submitting online application. For the credit card payment, only Visa, MasterCard, China UnionPay and JCB are accepted.
- ✧ SFO will issue a Remittance Advice to successful applicants stipulating the amount of the NLSFT loan to be disbursed and the loan disbursement date. The NLSFT loan will be disbursed to CUHK directly to settle applicants' tuition fee payment. Office of Admissions and Financial Aid will contact those applicants who have already settled the tuition fee payment via CUHK@link email to provide their bank account information, the loan will then be paid to their bank accounts.
- ✧ Applicants who have difficulties in settling the tuition fee payment and have not received the Remittance Advice before the tuition fee payment due date or the NLSFT disbursement date is later than the tuition fee payment due date may apply for deferment of tuition fee payment. For application details, undergraduate and postgraduate students can contact their respective College and academic department respectively.
- ✧ TSFS applicants will be informed of the financial assistance they are entitled under TSFS and NLSFT, if any, simultaneously through the TSFS result notification. If they wish to accept the NLSFT loan offered, they may download the required loan documents from SFO website and submit the duly completed loan documents and other required supporting documents by post or to the collection boxes at SFO's office on or before the deadline stated in their TSFS result notification.
- ✧ **If applicants attend postgraduate courses (by research)** that commence between March 2024 and February 2025, they should apply for NLSFT under the 2024/25 academic year. The application deadline is one month following the commencement of the course and in any case not later than 31 March 2025.
