



Guidelines on Application for Admission as Undergraduate Associate Student (Local) 2024-25 (2nd Term)

I. Admission Requirement

An applicant whose educational standard is considered adequate by the Department and the Board of the Faculty concerned may be admitted as an associate student to pursue an approved course of study not leading to a degree of the University.

II. Notes on Application

Please read the “[Regulations Governing Associate Students](#)” before completing the application form.

- (a) Application forms can be downloaded at www.cuhk.edu.hk/adm/asso/applicationform; OR can be obtained from the Office of Admissions and Financial Aid, The Chinese University of Hong Kong.
- (b) Completed application forms should be submitted to the Office of Admissions and Financial Aid in person or by post together with the following documents:
 1. Copy of Hong Kong Identity Card
 2. Certified true copies of credentials
 3. Application fee of **HK\$450** (by bank draft or crossed cheque made payable to “The Chinese University of Hong Kong”). Application fees paid are not refundable.

Incomplete submission of information/required documents may delay the application process or lead to the result of application not being processed.

- (c) Applicants may select course(s) to apply for based on the list of courses offered in 2024-25 (Website: http://rgsntl.rgs.cuhk.edu.hk/rws_prd_applx2/Public/tt_dsp_timetable.aspx). In the website, you may browse courses offered in 2024-25 (2nd Term) by selecting “2024-25 Term 2” for “Academic Term” under search criteria. If a course of your choice is not being offered in 2024-25, you will be notified after the release of 2024-25 Teaching Timetable in due course.
- (d) Application deadline: 30 October 2024

III. Tuition Fee (2024-25) (as of June 2024)

- Course load of 1-8 units : HK\$4,700.00 per unit
- Course load of 9-18 units : HK\$72,500.00 per term

NOTES:

The information collected from your application form will be used for the following purposes:

- (a) as a basis for selection of applicants for admission in the second term of the 2024-25 academic year as an associate student and other relevant or related purposes; and
- (b) for verifying information about the applicant’s candidature for public examinations and studies from the relevant institutions in Hong Kong and elsewhere; and
- (c) for identifying multiple applications and records of previous studies as a student in the University and other institutions; and
- (d) as part of applicants’ student records upon registration as an Associate Student, which will be held/transferred to departments/administrative units within the University as management information to facilitate verifications, communication, operations and planning.
